Retain access to competent advice and assistance, thereby ensuring that we are aware of relevant changes in legislation and 'Good Practice'.

Co-operate with other organisations to ensure that they are aware of any risk to their staff and other people posed by our activities, that we are aware of any risk to our staff from their activities, and that we comply with the relevant requirements of legislation.

Co-operate with other organisations on construction sites to ensure that they are aware of any risks to their employees and other people posed by our activities, that we are aware of any risks to our employees from their activities, and that we comply with the requirements of relevant legislation.
